This is in response to your request regarding a Record Review.

The Division of Criminal Justice Services [DCJS] is the repository for criminal history record information for the State of New York. As such, all requests for criminal history reports for Visa Applications and Letters of Good Conduct are handled through the Record Review Program. The Record Review Program allows an individual to review their statewide criminal or case (non-criminal) history information that is maintained on file by DCJS. Fingerprint images and a fee are requested for a Record Review. A fingerprint search is conducted and a response is made in the form of a dated memorandum (unsigned). This memorandum will state that: 1. There is no criminal history on file; or 2. There is non-criminal case history (job or license application) information on file, with a copy of the case history provided; or 3. There is criminal history information on file, with a copy of the criminal history report provided; or 4. There is non-criminal case history and criminal history on file, with a copy of the case and criminal history provided.


